NOTIFICATION

With a view to extend the benefits of equity and access to quality education to the economically weak students, keeping in mind the motto of "Sabka Sath Sabka Vikas", the University has introduced a financial support scheme for such students which will include fee waiver of all components of fee paid by students (except examination fee & hostel fee) on following terms:

Eligibility:

A full-time bonafide student studying at the University of Delhi in its Department/Institutions belonging to the following categories is eligible to apply:

S.No.	Family Income per annum (In Rupees) (Eligibility)	Fee Waiver (Percentage)
1.	Less than 4,00,000	Up to 100%
2.	4,00,000-8,00,000	Up to 50%

Process of application:

The fee waiver scheme will be implemented with effect from the Academic year 2022-23.

Documents Required:

The following documents must be submitted with the online application form for the fee waiver on the website of the University of Delhi.

- (a) Annual family income certificate for the Last Financial Year in the standard format issued by Tehsildar or equivalent Competent Authority and as per the committee's assessment.
(b) Copy of ITR of parents, wherever applicable.
- Copies of mark sheet of the last exam passed.
- Copy of bonafide student certificate in Degree/Postgraduate degree course.
- Copy of Fee Receipt mentioning the amount under different heads separately.
- Copy of Bank Pass Book showing the student's name, Account number, IFSC code and Photograph pasted at the appropriate place.

Note: Candidates with ER/Arrears of previous examination papers are not eligible for this fee waiver.

The University of Delhi celebrates diversity and is deeply committed to holistic and inclusive education. Understanding the need for affirmative actions as mandated in the constitution of India and to extend the benefits of equity, access and quality with excellence, both in letter and spirit, to the financially weak students, it proposes to begin a financial support scheme. This scheme is reflected through a fee waiver for economically weak students in the spirit of the Government's motto "Sabka Sath Sabka Vikas". The fee waiver includes all components of fee paid by students except examination fee & Hostel fee.

Eligibility:

A full-time bonafide student studying at the University of Delhi in its Department/ Institutions belonging to the following categories is eligible to apply.

S.No	Family Income (In Rupees) (Eligibility)	Fee Waiver (Percentage)
Category 1	Less than 4,00,000	Up to 100%
Category 2	4,00,000 – 8,00,000	Up to 50%

Candidates with ER/ Arrears of previous examination papers are not eligible to apply.

Documents Required:

The following documents must be submitted to DSW office along with the application form which can be obtained from DSW Office:

- (a) Annual family income certificate for the Last Financial Year in the standard format issued by Tehsildar or equivalent Competent Authority and per the committee's access.
(b) Copies of ITR of parents, wherever applicable
- Copies of mark sheet of the last exam passed.
- Copy of bonafide student in Degree/Postgraduate degree course
- Copy of Fee Receipt mentioning the amount under different heads separately.
Copy of Bank Pass Book showing the student's name, Account number, IFSC code and Photograph pasted at the appropriate place.

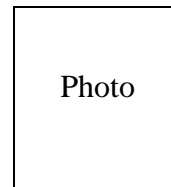
