- Students who have not cleared a minimum of five papers shall stand provisionally promoted (undertaking attached with the Form) but such students do not have to pay their semester fee (have to ignore fee payment tab) until they fulfill admission criteria. If they clear 5 papers after declaration of 2nd semester result, then they will be admitted and shall follow the steps for submission of Admission Forms

**For Vth Semester**

- All second year students are provisionally promoted to 5th semester.
- The students of LL.B. second year who have cleared a minimum of fifteen papers based on their results in LL.B. I/II/III Semester examination shall fill the Admission Form and pay the fee.
- Students who have not cleared a minimum of fifteen papers shall stand provisionally promoted (undertaking attached with the Form) but such students do not have to pay their semester fee (have to ignore fee payment tab) until they fulfil admission criteria. If they clear 15 papers after declaration of 4th semester result, then they will be admitted and shall follow the steps for submission of Admission Forms

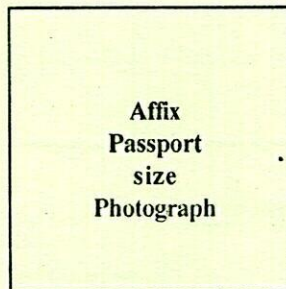
