- c) Be original for this contest and if possible support our theme/ topics. Do not infringe on any third- party rights (logos, music, intellectual property, etc).
- d) Include contact information of the maker : Name, email and phone number.
- e) Ensure what you have provided us is a high resolution output of your video. Small videos may be attached as a file to the email where possible as long as it does not cause the video to be overly compressed.

Certificates will be provided for best 3 accordingly and shall be uploaded on the official YouTube channel of Legal aid Society , Law Centre II.
