- 3. The nomination paper should be filled in, signed and certified in all respect. No column should be left blank. Incomplete form shall be rejected.
- 4. The filled up nomination paper duly verified by the Section Officer, Law Centre-II should be deposited in the sealed box kept in Room No 106, LC-II Office, Umang Bhawan on working days between 10:00 am to 05:00 pm, but in no case later than 3:00 pm, 19th September, 2024.
- Withdrawal will be permitted if it is submitted only in writing by the candidate in person before the PIC, LC II.
   No withdrawal shall be allowed after 12:00 noon 20th September, 2024.
