2. The nomination should be filed only on this form. Nomination filed on any other form shall be considered invalid.
3. The nomination paper should be filled in, signed and certified in all respect. No column should be left blank. Incomplete form shall be rejected.
4. The filled up nomination paper duly verified by the Section Officer, Law Centre-II should be deposited in the sealed box kept in Room No 106, LC-II Office, Umang Bhawan on working days between 10:00 am to 05:00 pm, but in no case later than 3:00 pm, 19th September, 2024.
5. Withdrawal will be permitted if it is submitted only in writing by the candidate in person before the PIC, LC II. No withdrawal shall be allowed after 12:00 noon 20th September, 2024.
