You being Head of the esteemed educational Institution where young adults are visiting daily in thousands. Further, on 24.11.2025, there is counting of votes for College Students Elections and there is high possibility that the winners may indulge in bursting of fire crackers.

Therefore, it is requested that following measures may be taken for sensitization and awareness of the students to enforce the complete ban on firecrackers.

1. A copy of the order of ACP Civil Lines of banning of bursting of Firecrackers must be displayed at the notice board of the college and other conspicuous places of the college campus.
2. All the Professors/ HODs/teachers and non teaching staff may be directed to brief the students in the class and other staff under their about the banning of firecrackers.
3. An undertaking must be obtained from all the contesting candidates before counting of votes that they or their supporters will not indulge in carrying or bursting of firecrackers anywhere.





ORDER

1. Whereas it has been observed that due to sudden increase in air pollution the health of general public is getting affected day by day and whereas, the cause in rise of air pollution is burning of firecrackers during the celebration of festivals/Programme.
2. And whereas, a ban has been ordered by the DPC vide No. F. No. 10/15/Fin/2020/Vol-11100-37 dated 14.10.2024 imposing Complete Ban on all kinds of firecrackers on manufacturing, storage, selling (including delivery through online Marketing platform) and bursting of all kinds of firecrackers upto 01.01.2025 in the territory of NCT of Delhi.
3. And whereas, safety and security of the health of general public and human being is a matter of serious concern. Bursting of firecrackers would cause extensive air pollution and releases metal particles, dangerous toxins, harmful chemicals and noxious gases which would form one of the main sources of air pollution. The air quality in the severe category may cause respiratory effects even on healthy people and severe health impact on people with lung/heart diseases. Thus it is necessary to take preventive action as per law to ban all type of firecracker.
4. Now, therefore, in exercise of the power conferred upon me by Section 163 Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023, read with Government of India, Ministry of Home Affairs, New Delhi notification No. U-11036/3/1978 (I) UTL dated 01.07.1978, I, Vinita Tyagi, Asstt. Commissioner of Police, Sub Division- Civil Lines, New Delhi do hereby order that no person shall manufacturing, Storage, Sale (including delivery through online Marketing platform) and bursting of all kinds of firecrackers including green crackers in the jurisdiction of Sub Division Civil Lines, Delhi in compliance of the announcement by Delhi Government.
5. These orders shall come into force with effect from 22.11.2024 shall remain in force up to 01.01.2025 (both days inclusive) unless withdrawn earlier.
6. Any person contravening this order shall be dealt with under section 223 of the Bharatiya Nyaya Sanhita (BNS) 2023.

As the notice cannot be served individually on all concerned, the order is hereby, passed *ex-parte*. It shall be published for the information of public through press and affixing copies on the Notice Boards of the offices of all DCsP, Addl. DCsP, ACsP, all Police Stations and offices of the New Delhi Municipal Corporation, Delhi Municipal Corporation, Public Works Department, Delhi Development Authority and Delhi Cantonment Board.
