The theme of the year focuses on "Bonded labour", also known as debt bondage, is a form of forced labour where individuals / families are compelled to work to repay a debt under exploitative conditions.

The Bonded Labour System (Abolition) Act, 1976, completes 50 years in 2025-2026, of its enactment on 15 October 2025 and notification for implementation on 7 February 2026.

Law declared bonded labour illegal in India and governments have made efforts towards their release from bondage and rehabilitation; however there seems to be gaps in enforcement, identification, and rehabilitation efforts. The National Crime Records Bureau data [victims between 2020–2022 is  $\uparrow$  2,837  $\rightarrow \downarrow$  667  $\rightarrow \uparrow$  1,600] suggests, the crime continues.
