**POINTS TO BE REMEMBERED:**

1. Students applying for the post of **Convenor** must have prior experience in Debating and preferably have won a national/international Debate Competition.
2. Students applying for the posts of **Convenor** and **Co-Convenor** must be in 2nd year/3rd year of 3 year LL.B, Law Centre – II. For all other positions any student of Law Centre-II is eligible to apply.
3. Each applicant can apply for only **one positions**.
4. Members must demonstrate proactive participation and responsibility. The Teacher Convenor reserves the right to remove any inactive member.

5. **Application Review:** Candidates will be shortlisted for Interview Round upon the basis of their Curriculum Vitae (CV) focusing on academic achievements, prior debating experience, leadership roles and other relevant accomplishments.
6. **Position Allocation Clause:** Teacher Convenor of Debate & Discussion Society, Law Centre – II, reserve the right to offer any position to a candidate, irrespective of the position(s) they have applied for, based on their qualifications and suitability. This ensures optimal placement of candidates in roles that align with their skills and Society's needs.
