## ADMISSION / RE-ADMISSION NOTICE (2025-26) Attention: All eligible Students, seeking admission to LL.B. 2<sup>nd</sup> & 3<sup>rd</sup> Year

All those students of LL.B. 1<sup>st</sup> & 2<sup>nd</sup> Year (Academic Session 2024-25), who have not been detained due to shortage of attendance, are being promoted <u>provisionally</u> to LL.B. 2<sup>nd</sup> and 3<sup>rd</sup> Year respectively. All the provisionally promoted students are permitted to attend their LL.B. Classes.

- 1. All the students of LL.B. 1st Year and 2nd Year, who have already passed 5 or 15 papers respectively and have not been detained in LL.B. II/IV Term, are eligible for admission to LL.B. 2nd and 3rd Year during the Academic Year 2025-2026.
- 2. Students are hereby advised to submit their Admission Form (available on the website of Law Centre-II OR it may also be obtained from the office of Law Centre-II till the availability of the same), duly filled in all respect, in the office of Law Centre-II along with the following documents from 28.7.2025 to 5.8.2025 during 11:00 a.m. to 1:00 p.m. & 2:00 p.m. to 3:00 p.m.
  - (i) Self-attested photocopies of all the 'Statement of Marks' and photographs.
  - (ii) Attach the copy of memorandum, issued by the Examination Branch, if any.
  - (iii) Undertaking, if required.
- 3. It may be noted that the LL.B. Students of Law Centre-II are initially required to approach for getting their work done or submit their applications and all other documents to the following persons, dealing with the LL.B. Students: -

- Students, who were detained to appear in their LL.B. III Term and V Term Examinations during the year 2024-2025 or before due to shortage of attendance, may also take re-admission in III Term and V Term respectively.
