We are excited to announce that the Debate and Discussion Society is going to Induct its members through the Induction Debate competition (IDC-2025) to be held on 15th November 2025 from 9 AM onwards.

The Debate and Discussion Society of Law Centre-II aims to foster a culture of critical thinking, articulation and intellectual exchange among law students. The Induction Debate Competition is the official process to become a member of society. The Bonafide students of Law Centre-II are allowed to participate in order to be a member of the society for the academic session 2025-2026.

General Guidelines:-

- 1. Eligibility Criteria: All Bonafide students of Law Centre-II are welcome.
- **2.** Language: The speech must be delivered entirely in Hindi or English. Switching between the languages is strictly prohibited.
- 3. Time limit: Participants will have one minute to deliver their speech online through a video in the initial screening process for selection to final round induction debate 2025. In the final round IDC 2025 participants will have three minutes to deliver their statement either supporting the motion or speaking against it from topic listed below. Warning bell at 2 minutes. Crossing the time limit may affect score.
- **4. Presentation tips:** Keep your content original, powerful and relevant. Reading from paper or phone is discouraged, maintain eye contact, clarity and confidence.
- **5. Judging criteria:** Content, Knowledge of the subject, Confidence, Command on Language, Time Management, Dress Code and Conduct.
- **6. Judge's Discretion-** The judge's discretion are final and binding. Based on their performance, participants will be inducted as members.
- 7. Selection Process -Two round selection process. First round includes a recorded speech submitted on the google form link online on any one of the following topics provided for IDC 2025. Second round includes Induction Debate Competition of selected participants choosing any sides of their choice from the topics listed below-

- The Importance of the Invention of "Zero/Shunya" in Technological Evolution and the Role of "Shunyata/Meditation" in Human Evolution!
- The Road Ahead for Humanity Knowledge-based Culture Vs Commerce-based Culture?
