ATTENTION: LL.B. 2nd YEAR STUDENTS

In the beginning of the academic year 2025-2026, all the students were promoted provisionally to LL.B. 2nd Year (III Term) in anticipation of that they will become eligible for promotion to the next classes on declaration of result of LL.B. II Term. They were permitted to attend the classes to save them from the loss of course of study and also to count their attendance for the purpose to meet the mandatory attendance criteria of 70% out of the total lectures delivered.

Now, ample opportunities have been given to them and a considerable time has passed but the following students of LL.B. III Term could not produce the **"Statement of Marks"** in support of their eligibility for promotion to the next term and also to confirm their admission in the respective term.
