- Withdrawal will be permitted only if it is submitted by the candidate **in his/her writing and in person** with the **Law Centre-II Identity Card** in the **Office of the Section Officer, Law Centre-II. No withdrawal shall be allowed after 12.00 noon on Friday, the 11th September, 2026.**
