Logo Designing Competition- Notice for Students

Law Centre-II is celebrating its Golden Jubilee in the year 2021. As part of the Golden Jubilee celebrations, a logo designing competition is being organised. The competition is open to all **current students of Law Centre-II only**. The logo will be unveiled at the inaugural event of the Golden Jubilee celebrations in September, 2021 and will be used for all events of the Golden Jubilee celebration throughout 2021-22. The winner will also be awarded a certificate of appreciation from the Professor-In-Charge, Law Centre-II.

Terms and Conditions of the Competition:

1. The logo should be the original work of the student. It should not violate the Copyright Act, 1957 or any intellectual property rights of third parties. The participating student would be solely responsible for any violation and legal consequences, if any, of the violation of this condition.
2. The logo should not violate the provisions of the Emblems and Names (Prevention of Improper Use) Act, 1950.
3. Entries can be submitted by an individual or by a team comprising of maximum three students. Multiple entries by the same student or team are not allowed and will lead to disqualification.
4. All entries will be the sole property of Law Centre-II for institutional use. Law Centre-II also reserves the right to make any amendments to the design, if required.
5. There should be no plagiarised, offensive or objectionable content in the design. Any such content will lead to disqualification of the student as well as necessary disciplinary action, if required.
6. The logo should be submitted in high resolution jpg, pdf format only. It should be prepared on a suitable digital platform and be capable of being copied and used on website and social media platforms as well as in print media. The logo may also contain a meaningful motto.
7. The winner will be selected by a committee of teachers constituted for this purpose. The result will be declared by September 08, 2021 via email and on the website of Law Centre-II.

The email should contain the **logo design file and a covering letter** stating the following:

I have no objection in the logo being modified and used in a suitable manner for the official purposes of Law Centre-II.
