Second Lecture Series 'SAMVAD'

LECTURES BY FOREIGN SCHOLARS

The Lecture Series 'Samvad' was started in the Law Centre-II under the aegis of Dr. V. K. Ahuja, In-Charge, Law Centre-II, in the beginning of the academic session 2017-2018. It was taken forward in this semester and various lectures have been delivered in this series.

The First Lecture in this series was delivered by Ms. Molina Asthana, Principal Solicitor, Victorian Government Solicitor's Office, Australia on January 18, 2018. She interacted with the students and faculties on the theme of Legal System and Practice of Law in Australia. She also spoke about the available avenues for Indian law students in Australia.



Prof. Ved P. Nanda, Director, The Nanda Centre for International and Comparative Law, University of Denver Sturm College of Law and Shri Narinder Singh, Former Additional Secretary, Ministry of External Affairs were the key speakers for the panel discussion organized under the Lecture Series 'Samvad' on January 24, 2018. It is a matter of great pride that Prof. Ved P. Nanda is an Honorary Professor at University of Delhi.



The Panel Discussion was based on the theme of Kulbhushan Jadhav Case: The Road Ahead.

The Third lecture under the Lecture Series was delivered by Prof. Kennedy Gastorn, Secretary General, Asian African Legal Consultative Organization on March 19, 2018. He interacted with the students and the faculties on the theme of Role of AALCO in the development of International Law.



GST SAMWAD (INDIAN PANEL): INDIA GST

Law Centre II and GSTStreet together conceptualized the biggest event on GST yet. GST Manthan was a coming together of big corporate, CEOs, Legal Minds, Taxation Experts, Eminent Professors, Bureaucrats, Senior Executives and Law Students. As the word “Manthan” goes, the event aimed to stir up a dialogue on the New Indirect Tax Regime in the country and further raise awareness about it.

GST Manthan was designed to achieve its goal with a 3 tier approach to GST. One of them was GST Samwad (Indian Panel) which was organized on February 17, 2018. The Panelists for the event were Mr. R. Sridhar, Mr. Sachin Menon, Mr. Bimal Jain, Mr. Amit Bhagat and Mr. Somesh Arora.

The Panel Discussion was moderated by Shri Ameya Kunte. The Panel enlightened the participants on GST Registration & Economic Survey, 2018, Anti-profiteering, Supply Chain and E-Way bill, Input Credit Matching, Compliance Concerns, Litigation and overall Industry Experience amongst diverse arenas.

Mr. R. Sridhar highlighted the procedural and practical issues in the arena of cooperative federalism. An optimistic take on the GST brought forth the increased compliance, which was lacking prior to the coming of GST, because of the lack of control over the manufacturers. The new system is encouraging transparency driven by technology, because of which, the registrations for tax has been raised from 2016-17 onwards, there has been a spike in the indirect tax revenue. He also highlighted upon the fact that the GST Network is not still developed, and that the Trial version has been given limited time. It has to be allowed 6-8 months, and more clarity regarding the inter-state movement E-Way bill is also missing.

Mr. Sachin Menon enlightened on how the multiple tax system assessments were unified into one, and that, at the business and operation level, GST proposes to establish one national and one

tax. It is of foremost importance of any businessman irrespective of any State, and he has to only file the GST Returns, which is easier to comply.

Mr. Bimal Jain brought forth the positives post GST. GST in the long run will result in the increase in the revenue for the Government, as well as for the businessmen, as it will give profitability by abolishing the multiplicity of taxes. It also has the capacity to curtail the printing of fake invoices. With GST it is getting easier to catch the misdemeanors, as there is absence of human intervention.



Mr. Amit Bhagat also highlighted foundational credits with certain operational challenges. As, where the filing of returns have been missed, there is absence of a concrete remedy. Also, bottlenecks are to be countered to implement the entire compliance structure, as the technology is capable of accommodating such a complex mechanism, but some more time is needed for rectification and acclimatizing the new technology to fit in the new regime. Also, advancement would mean nothing unless one gets access to the portals. He also said that GST is a huge experiment for which India was not prepared technologically.

Mr. Somesh Arora dealt with whether the GST should be continued, and suggested improvements. The purpose of the E-Way Bill is to catch the evaders, and to catch movement of goods, but at the same time the honest tax payers have to be rewarded.

GST SAMWAD (INTERNATIONAL PANEL): GLOBAL TAX REFORMS (FOREIGN SCHOLARS)

The Panel Discussion was moderated by Shri Rishabh Sawansukha, Founder, GSTStreet & TAXStreets. The Panel enlightened the participants on the Indirect Tax Reforms and UAE Experience, International Tax Scenario, Invoice for Tax Purposes, Significant economic Presence and DTAA, and Tax administration Automation and the road ahead.

Mr. Clarence Ellis, Founder, Taxnomics, United Arab Emirates and Mr. Kamal Agarwal, highlighted upon the practices prevalent in different countries like Australia, UAE, which are open for business, and the issues related transparency.



Mr. Virender Chauhan, Member, Indirect Tax Committee, ICAI and Dr. Rajni Abbi, Associate Professor, Law Centre-II, University of Delhi dealt with the Double Taxation System, Reverse Charge Mechanism, E-WAY Bill amongst other issues.

Mr. Sanjay Sharan talked about the importance of trade outreach programmes all over India, which would promote awareness by introducing courses in institutes.

Mr. Mayank Sawhney, Managing Director, Max Growth Consulting, United Arab Emirates delved into the taxation system in UAE, and analyzed the pros and cons of the same.

Seminars and Conferences

NATIONAL SEMINAR ON 'RIGHTS OF PERSONS WITH DISABILITIES: CONTEMPORARY DEVELOPMENTS'



Law Centre –II, University of Delhi in collaboration with Association of Disabled People organized a day-long National Seminar on ‘Rights of Persons with Disabilities: Contemporary Developments’ on 12th February 2018. Sh. Pranab Mukherjee, Former President of India inaugurated the Seminar. The Seminar provided a platform to students from various law schools and members of allied disciplines to have a qualified discussion on the rights of persons with disabilities. Prof. Ved Kumari, Dean, Faculty of Law welcomed the participants and emphasized that society needs to understand the concept of disability through the perspective of persons with disability. Prof. Yogesh Tyagi, Hon’ble Vice-Chancellor of University of Delhi addressed the august gathering and expressed his gratitude to former President of India for his gracious presence on this auspicious occasion. Shri Pranab Mukherjee, the Chief Guest for the inaugural session highlighted that the disability rights’ debate is not about the enjoyment of specific rights but about ensuring the equal effective enjoyment of all human rights, without discrimination, by people with disabilities. He stated that the primary responsibility for ensuring respect for the rights of persons with disabilities rests with the government. The Government of India has taken various steps to provide equal opportunities to persons with disabilities by enacting several Acts

and implementing various policies and schemes for the empowerment of persons with disabilities. Shri Pranab Mukherjee emphasized that “The Rights of Persons with Disabilities Act, 2016” explicitly envisages civil and political rights of persons with disabilities in addition to envisaging the economic, social, and cultural rights of such persons. It reflects a paradigm shift in thinking about disability from a social welfare concern to a human rights issue. Thus, it is a milestone in struggle for equal opportunities for disabled people in India.



Dr. V.K. Ahuja, In-charge, Law Centre-II extended vote of thanks and spoke about right to access of blind, visually impaired persons to published material in accessible format as recognized under Marrakesh Treaty on Blind, Visually Impaired and Print Disabled Persons to which India is a party. Mr. Pradeep Raj, International Para Athlete and General Secretary, Association for Disabled People, Ms. Ira Singhal, IAS, Ms. Neha Aneja, Assistant Professor, Faculty of Law, University of Delhi also addressed the gathering. The Seminar was attended by more than 900 students from various law schools and it was coordinated by Dr. Pinki Sharma, Associate Professor, Faculty of Law, University of Delhi with the help of student convener Mr. Tejaswi Sharma.

SEMINAR ON RIGHTS OF WOMEN IN INDIA: CONTEMPORARY DEVELOPMENTS

Law Centre-II organized a seminar on Rights of Women in India: Contemporary Developments on March 16, 2018. Shri Ram Narayan Dudi, Member of Parliament, Rajya Sabha and Ex. Cabinet Minister graced the occasion with his presence as the Chief Guest and Shri Manjinder Singh Sirsa, MLA, Rajouri Garden and General Secretary, DGPC as the Guest of Honour. The Resource Persons for the Seminar were Ms. Monika Arora, Senior Advocate, Supreme Court of India, Smt. Sarita Chaudhary, In-charge of Beti Bachao Beti Padhao, Delhi, Ex-Mayor/SDMC, Dr. Amna Mirza, Educationist, Assistant Professor, Delhi University and Ms. Charu Pragya, In-charge BJYM, UP, In-Charge, National Legal Cell. It is a matter of great pride that Ms. Monika Arora is an alumnus of Law Centre-II.



PANEL DISCUSSION ON PASSIVE EUTHANASIA: ISSUES AND CHALLENGES

Law Centre-II, University of Delhi organized a panel discussion on issues and challenges of Passive Euthanasia on March 28, 2018. The discussion was moderated by In-charge of Law Centre-II, Dr. V K Ahuja. The panelists were Justice K G Balakrishnan, Former chairperson NHRC and Former Chief Justice of India, Shri K T S Tulsi, Member of Parliament, Rajya Sabha, Shri Adish C Aggarwala, President of International Council of Jurists & Chairman, All India Bar Association, Shri Jaiveer Shergill, spokesperson of INC. Dr. Pinki Sharma organised this event as the director along with student volunteers.

Panelists were of the opinion that “Supreme Court legalizing passive euthanasia is a path-breaking judgment to minimize the misuse of this tool, and it upheld the right of every citizen to die with dignity when living is not possible. It provides the right to control life and death. But Indian executive has to be very cautious that passive euthanasia should not be misused as a tool to take the life of someone who failed to afford the resources to get the medical treatment done, so the burden is on the legislature and executive to ensure fair implementation of passive euthanasia, so that it should not become a weapon to kill the people who failed to afford treatment to their lives with utmost medical care. Panelists viewed that if the guidelines provided by the Supreme Court of India get codified, it will reduce the number of cases in the courts. This tool may not be the best thing today, but it will capture the future.”



DISCUSSION PROGRAM ON BUDGET 2018-19 AND ITS IMPACT ON HIGHER EDUCATION

help desk was organized by the DSLSA.

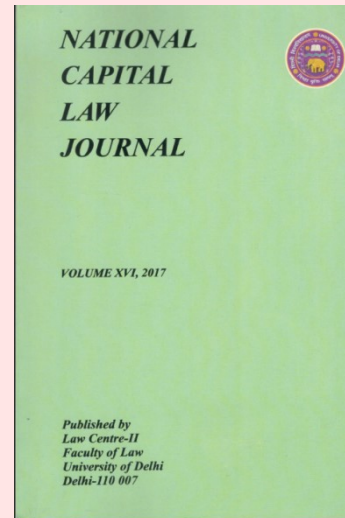

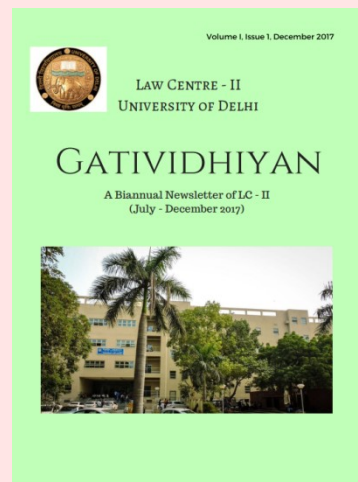
Releases

JUSTIFIED 2018

The Moot Court Society under the convenorship of Dr. Mahavir Singh organized S. K. Puri Memorial Moot Court Competition, ‘JUSTIFIED’ 2018 from March 23 to March 25, 2018. The Moot Court was organized in collaboration with Mr. Sacchin Puri, Senior Advocate, Supreme Court of India.



The event was inaugurated by the Hon’ble Mr. Justice I. S. Mehta, Judge, Delhi High Court. The final rounds were judged by Hon’ble Mr. Justice Vibhu Bakhru, Judge, Delhi High Court and Hon’ble Mr. Justice A. K. Pathak, Judge, Delhi High Court. The valedictory session was presided over by Hon’ble Mr. Justice A. K. Sikri, Judge, Supreme Court of India.

A total of 40 teams from all across the country participated. Team comprising of Mr. Rajesh Jha, Ms. Kainat Singh and Mr. Arsh Singh from Army Institute of Law, Mohali were adjudged to be



the winners followed by Mr. Jaideep Singh Lalli, Ms. Bhavyata Kapoor and Ms. Sonal Aggarwal from UILS, Punjab University. Ms. S. S. Shrilakshmi from HNLU, Chattisgarh was awarded the Best Researcher Award and the Best Memorial was awarded to the team from SASTRA University. Mr. Vansh Vermani from VIPS, Delhi was adjudged the Best Speaker (Male) and Ms.

Ushashi Nan from Symbiosis Law School, NOIDA was adjudged the Best Speaker (Female).

GST ADALAT

Goods and Services Tax is a fast paving way for growth and has provided much needed stimulus to ease of doing business in India, but adaption to it comes with its own challenges. To make the legislation more efficient and implementable it is important to acknowledge the shortcomings and fallacies of GST. The way democracy cannot function well without a formidable opposition, a best piece of legislation cannot be drafted without dissenting views. In this background, GST Adalat was organized as India's first Mock Adalat dedicated to GST on February 17, 2018.

The facts of the case involved the intricacies of the GST. The Mock Adalat discussion revolved around the contested issues of free supplies, Input Tax Credit prohibition, Open Market



valuation, Promotion Supplies, and FAQs issued by the Ministry of Finance amongst the other perplexing notions involved in the obscure Tax Reform.

The bench was presided over by Senior Advocate Mr. Arvind P. Datar, Senior Advocate N. Venkataraman and Senior Advocate Mr. Rohan Shah. Submissions were made by Mr. Sujit Ghosh, Partner, Advaita Legal as Petitioner, and Monish Panda, as the Respondent. Mr. Karthik Sundaram was the moderator.

The broad issues of the jury revolved around the notion of “goods”, disposed by way of gift for the purposes of Section 17(5)(h) CGST Act, and availing input tax credit on free supplies. Also, whether price is the sole consideration in the supply, and the payment of GST on the open market value of product manufactured was discussed. The writ jurisdiction of the High Court as a substantive bar to the SGST authorities from initiating any further action under their respective



state provisions was also delved upon. The questions by the Judges called upon the interpretation of various contested provisions of the Act engaging the counsel to present clarifying the position taken by various judicial precedents, and establishing its relevance to the facts of the present case.

Finally, Senior Advocate N. Venkataraman, and Senior Advocate Mr. Rohan Shah enlightened the panelists by making concluding observations that “consideration” is the foundation of GST Law. Senior Counsel Mr. Rohan Shah elaborated upon the practices prevalent in other countries like United Kingdom and Ireland.
